309. ASSIGNMENT AND TRANSFER	
1. Authority	<p>The assignment and transfer of administrative, professional and support employees within the district shall be determined by the management, supervisory, instructional and operational needs of the schools and the school district.</p>
SC 508, 510	<p>The Board shall approve the initial assignment of all employees at the time of employment and when such assignments involve a transfer from one building or supervisor to another or involve a move to a position requiring a certificate or credentials other than those required for the employee's present position</p>
23 Pa. C.S.A. Sec. 6344.3, 6344.4	<p>Each applicant for transfer or reassignment shall be required to submit an official child abuse clearance statement unless the applicant is applying for a transfer from one position as a district employee to another position as a district employee and the applicant's official child abuse clearance statement is current.</p>
SC 111 Pol. 317	<p>Each applicant for transfer or reassignment from a position without direct contact with students to a position with direct contact shall be required to submit criminal background checks as required by law. Such applicants shall report, on the designated form, arrests and convictions as specified on the form. Failure to accurately report such arrests and convictions may subject the individual to disciplinary action up to and including termination and criminal prosecution.</p>
2. Delegation of Responsibility	<p>The Superintendent or designee shall provide a system of assignment or reassignment for district employees that include consideration of requests for voluntary transfers.</p> <ol style="list-style-type: none"> 1. Impact of proposed assignment on the educational program. 2. Employee's background, experience and preparation for the position. 3. Employee's success in former positions.

4. Recommendations of the employee's administrative supervisors.
5. Administrative and operational efficiency advanced by the proposed assignment.

The Superintendent, in considering any assignment or transfer, shall assure that low-income students and minority students are not taught by a greater volume of unqualified, out-of-field or inexperienced teachers, than other students.

Vacancies shall be publicized to all appropriate employees.

This policy shall not prevent reassignment of **an employee** during the school year for good cause, **as determined by the Board.**

Negotiated collective bargaining agreements shall supersede the provisions of this policy when they prescribe conditions enumerated in or affected by this policy.
