Ferndale Area School District has involved stakeholders including, but not limited to, parents, students, community members, board members, business leaders, and teachers. The District holds monthly Curriculum Meetings in which a plethora of topics are discussed, including Federal Grants and most recently including the various ESSER grants. Additionally, a priority list of identified needs to be addressed with ESSER funding was put out to all of the above stakeholders for public comment via a Microsoft Forms survey to rank in order of perceived value of ESSER utilization to students, teaching, and learning.

Please explain the LEA(s) proposed timeline for providing services and assistance to students and staff. (3000 characters max)

The timeline for providing services and assistance can be retroactive to March 2020. Learning loss, instructional supports and mental health programming were initiated soon after the first closure of the District buildings. After school tutoring, homework room, and online supports were provided during the second semester of the 2020-2021 school year. Extensive summer programming for K4-12th grade students is ongoing, well attended, and well received. Students and staff will receive updated educational technology and learning tools with ESSER funding.

The following initiatives will be implemented with ESSER funding: - replacement of student technology (iPads) - purchase of EdInsight software to provide student assessment data management and collection for interventions and supports - Assurance Counseling (now R.E.A.C.H.) to provide behavioral and mental health services - Full time School Psychologist - Web filtering software and hardware replacement and upgrades - replacement of outdated

vision and hearing screening tools - new software to control HVAC and climate control - Upgrade STEAM Lab and Library learning spaces with appropriate technology, furniture and instructional tools.

FASD is implementing the hiring of a second Reading Specialist and MTSS Coordinator. These additional positions will allow for intensive monitoring, evaluation and interventions beyond FASD historical norms. Additionally, the addition of EdInsight will allow for organization and analysis of student benchmarking and assessment data to determine academic and other student needs that are identified. Student placement, intervention tiers and levels of interventions will be a data driven process involving parents, teachers, MTSS staff, specialists and others as needed to provide supports to students and teachers to minimize and bridge gaps related to any learning loss.

Please describe the LEA(s) proposed procedures for evaluating local COVID-19 impacts in relation to education programming and delivery. (3000 characters max)

Areas of emphasis should include:

- Documenting learning loss associated with extended school closure;
- Outlining the development of local continuity of education plans over the course of emergency response efforts; and
- Detailing supports for vulnerable student populations and families.

Learning loss will be documented within the EdInsight data collection process. Several metrics associated with student achievement will be collected and analyzed. Utilizing school staff, ESSER funding various programming will be offered and implemented including summer tutoring, credit recovery, academic camps, after school tutoring, classroom push-in and pull out student academic services, Tier I, II, and III interventions, ESL services, expansion of STEAM related clubs and activities, etc. Continuity of education was maintained throughout the educational process by maximizing and mobilizing all the use of all available staff to focus on socially distanced classroom teaching. Additional options were permitted for students to live stream into classrooms from home to allow for the best possible substitute for in-person learning. During the course of the emergency response every effort was made to provide a safe learning environment for face-2-face learning, offer live streaming options for families choosing to learn from home and providing internet services for families not having online services in their home. ALL students in addition to venerable student populations were closely monitored for attendance, academic progress, social emotional needs and provided free meals through the CEP program. Remote families were able to pick up meals for students unable to attend face-to-face learning. Through another program, weekend feeding items were provided for eligible students as well. During the 2020-2021 SY, FASD partnered with Assurance counseling to provide social services, behavior supports and additional help with families mental health needs.

Short Term - FASD is utilizing Local Funding, ESSER I and other Federal Grants (Title IV) to provide needed supports for the 2020-2021 SY. ESSER II funding will provide needed funding for further scaling of technology, upgrading aging technology, upgrading aging infrastructure, upgrading and replacing physical plant HVAC, expanding our mental health service provider to two full time staff, expanding our school psychologist to full time and related infrastructure.
